TUITION CONTRACT

I understand the financial responsibility involved and I hereby pledge to pay monthly the contracted tuition amount. Payment will begin before the student enters school and be made payable to Anaheim Discovery Christian School or ADCS. If I am late paying my tuition which for full year payment is August 18th or 1/2 year payment August 18th or January 8th, late charges **(\$150.00)** will apply. **If I am delinquent over 1 month, I understand that I give permission to ADCS to charge my credit card for the amount due, including late fees and I may be expelled from the school.**

I hereby agree that the student to whom this contract is given will remain an enrolled student at the Anaheim Discovery Christian School for at least TWO YEARS. The only manner in which a student may transfer schools is by paying the full tuition for those two years and summer school. In the event the student must withdraw from the school for any reason, the person who signs this form is financially and personally responsible to pay the remainder of the tuition to ADCS. If they refuse to do so, the person who signs this form authorizes ADCS to charge the credit card listed in this contract for the full amount due to ADCS or send the account to a collection agency.

This school reserves the right to refuse admittance to a child whose parents/guardians allow their account to become more than 30 days delinquent. This school reserves the right to refuse admittance to a child deemed, by the school, disruptive to the educational process of the school and or does not behave in agreement to the student handbook. This school also reserves the right to refuse admittance to a child which the school feels it cannot meet the educational needs of the child.

By signing this agreement, the parties of this contract agree that any claim or dispute arising out of or relating to this agreement or any aspect of the school relationship may be pursued in a court of law, with venue in Orange County and application of California law. The parties recognize that for the school to pursue the collection of any delinquent accounts is time-consuming and expensive compared to the amount of tuition, book fees and registration fees the school charges. Accordingly, the parties agree that each side will bear their own attorney’s fees and costs in any such action, EXCEPT for such actions where the school must initiate a civil action to collect such registration fees, book fees, and/or tuition, in which case, the prevailing party shall be entitled to recover its attorney’s fees and costs.
